2. COURSE DESCRIPTION			
2.1. Course objectives	<p>Christian faith is based on God's revelation revealed in the historical person of Jesus from Nazareth, who was recognised by his disciples as the promised Messiah and who is confessed by the Church as the Son of God and the only saviour of the world. Christ's revelation is, therefore, the starting point and the basis of every kind of Christian theology and the whole mission of the Church and life of Christians. It is, in a special way, in the heart of fundamental theology, whose task is to study and rationally explain the basis and meaning of Christian faith. The main goal of the course is to systematically-theologically study and present uniqueness and specificity of Christian revelation for the life of the human being, the Church, and the world. Therefore, it will provide an introduction to the concept of revelation, present its Biblical meaning, and analyse its theological and doctrinal elaboration during various periods of history of the Church. It will also be situated within the relation with philosophical reflection and contemporary culture. Its richness and relevancy for today will be pointed out. In the spirit of the Dogmatic Constitution <i>Dei verbum</i> of the Second Vatican Council, the relational dimension of the divine faith that carries the human being to a fuller truth about himself/herself, about the final purpose, about God and the meaning of human history will be pointed out. Theology of revelation issues a call to the Christian and every human being to get to know and live out the novelty of life witnessed by Jesus Christ. It is, therefore, of utmost importance for pastoral activity of the Church and for Christian testimony in the contemporary world.</p>
